VERIFICATION OF CREDIT HOURS FOR NON-DEGREE STUDENTS TAKING PREREQUISITES FOR ADMISSION

A student who is not enrolled in a degree or certificate program is eligible for Stafford Loans for a period of up to one year only if the student is taking coursework necessary for his or her enrollment in a degree- or certificate-granting program. The student is eligible for loans for one consecutive 12-month period beginning on the first day of the loan period for which the student is enrolled.

To be eligible under this exception, the student must be taking courses that are prerequisites for admission. If the student is taking courses to raise their GPA in order to be admitted, the student does not qualify for loans under this exception.

An example of the preparatory coursework exception would be a student who already received a B.S. degree, but needs additional hours of specialized undergraduate coursework to enroll in a graduate program. The following courses are acceptable as prerequisite courses for the Master's Degree program in Speech Pathology:
